

# **Licensing Procedures**

Pentecostal Assemblies of the World, Inc.

Diocesan: The Honorable Bishop Jones Foote

Listed below are the application procedures for eligibility of Fellowship Certificates, Ministerial Licensing and Ordination by the Pentecostal Assemblies of the World, Inc. (P.A.W.).

#### **Fellowship Certificates - Applicants shall:**

- Have completed the Fellowship Certificate application and have it signed by their Pastor.
- Submit the application and \$25.00 fee to the CSC License Committee during council hours of operation.
- Fellowship Certificates must be held for one year before applying for Ministerial License.

### **Ministerial License - Applicants shall:**

- Have a current Fellowship Certificate with the Colorado State Council. Fellowship Certificates must be held for one year before applying for Ministerial License.
- Have completed the Ministerial Introduction Course through Aenon Bible College.
- Have completed the Ministerial License application and have it signed by their Pastor and District Elder.
- Submit the complete application with two copies of "Certificate of Completion" from the Ministerial Introduction Course (Aenon Bible College) and \$75.00 (non pastor); \$150.00 (pastors) fee to the License Committee during council hours of operation.

#### **Ordination (June Council Only) - Applicants shall:**

(Please note: Passing this course does not make the applicant eligible for Ordination; that decision is left to the Diocesan Bishop).

- Have their Pastor contact the CSC License Committee Thursday during the February council and inform them of your intent for ordination.
- Have completed the Ordination Course through Aenon Bible College.
- Have a current Ministerial License with the Pentecostal Assemblies of the World, for at lease one year.
  Submit two copies of "Certificate of Completion" from the Ordination Course (Aenon Bible College) and \$100.00 (non pastor); \$150.00 (pastors) fee to the CSC License Committee on Thursday's Council session.

## Renewal of Fellowship Certificates, Ministerial and Ordination Licenses

All renewals will be processed through the CSC Licensing Committee. Please submit appropriate fee with the completed appropriate data form to the CSC License Committee. Renewals submitted after 12 noon Saturday day will be processed after the Council and will be reported on the next Council's report.
